Please be advised that it is time to renew your annual certification(s) for calendar year 2020. This is in accordance with the City of Montgomery ordinance #27-2012. The fee is \$175.00 per certification. All certifications expire on December 31st of each year and must be renewed annually. For your convenience, we have posted all renewal documents online. To view and print the documents, follow the below instructions.

- Click on 'Inspections and Investigations'
- Click on 'Inspection Forms'
- In the center is a copy of the application and all Contractor Checklists

Reminder: Sprinkler, Suppression, and Fire Alarm contractors will be required to submit Service Reports of all service performed on fire protection equipment. Monthly reports can be emailed to Captain Searcy at ssearcy@montgomeryal.gov. **All new installs shall be permitted, paid for, and picked up before work is started. Failure to do so will void your certification and will result in a fine.**
