

ORDINANCE NO. 14-2019


WHEREAS, Pursuant to Section 11-46-23 of the Code of Alabama, 1975, the Council of the City of Montgomery adopted Ordinance No. 4-2012 setting forth the nine Council Districts; and

WHEREAS, Pursuant to Section 11-46-24 of the Code of the Alabama, 1975, the Council of the City of Montgomery adopted Ordinance No. 61-2014 With Appendices A & B setting forth the Municipal Voting Precincts; and

WHEREAS, due to a change in ownership of the voting cite for 5A, Fresh Anointing House of Worship, 150 East Fleming Road has changed to Alabama Florida Episcopal District Convention & Empowerment Center Complex (AFED Conference Center), 150 East Fleming Road and will remain as 5A voting cite:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MONTGOMERY, ALABAMA, that Ordinance No. 61-2014 5A, Appendix A & B are hereby amended to be 5A Alabama Florida Episcopal District Convention & Empowerment Center Complex (AFED Conference Center), 150 East Fleming Road as the voting cite for 5A, and all previous ordinances establishing voting precincts for the City of Montgomery are hereby superseded to the extent that they are inconsistent herewith.


APPENDIX A

5A Alabama Florida Episcopal District Convention & Empowerment Center
 Complex Center (AFED Conference Center)
 150 East Fleming Road

Commence at the intersection of the centerlines of McInnis Road and Narrow Lane Road, said point being the Point of Beginning; thence Southeast along the centerline of Narrow Lane Road to its intersection with the south line of Section 9 T15N R18E; thence West along the centerline of said Section 9, continuing West along the south lines of Sections 8 and 7 T15N R18E to the southeast corner of Section 12 T15N R17E; thence West along the south line of said Section 12 to its intersection with the centerline of CSX Transportation Railroad; thence North along the centerline of said railroad to its intersection with the centerline of West South Boulevard (US Highway 80); thence East along the centerline of West South Boulevard (US Highway 80), continuing East along the centerline of East South Boulevard (US Highway 80), to its intersection with the centerline of Hannon Slough; thence Southwest along the centerline of Hannon Slough to its intersection with the centerline of Narrow Lane Road; thence Southeast along the centerline of Narrow Lane Road to the Point of Beginning.
